A PARTNERSHIP CONNECTING THE COMMUNITY

The Midway Chamber of Commerce Community Directory is a joint project of the Midway Chamber and the *Midway Como Frogtown Frogtown Monitor*. The partnership began in 1995 when a former Midway Chamber president reached out to the *Monitor*, a longtime Chamber member, to consider producing the annual book for the Chamber. Prior to this, the *Monitor* had been used solely as a distribution vehicle for the Chamber Directory, since the circulation footprints of the *Monitor* and the Chamber Directory do widely overlap. This new proposal for the *Monitor*, however, was based on the hope that the collaboration between the community newspaper and the civic and commerce association could further generate additional benefits and synergies beyond the publication of the Directory.

Today, the Chamber Directory is produced on an annual basis, with the Chamber providing the editorial copy for the book and the staff at TMC Publications, owner of the *Midway Como Frogtown Frogtown Monitor*, selling advertising for the Directory, producing ads, and laying out the publication. TMC Publications also handles the printing of the Directory. Each year a portion of the revenue from ad sales in the Directory are returned to the Chamber.

MIDWAY COMMUNITY COUNCILS

For more than 50 years, a hallmark of Saint Paul's diverse neighborhoods have been the District Planning Councils. These neighborhood organizations are an important part of the Midway, and are increasingly linking residents and businesses. Each Council is run by an elected Board of Directors, often including business representatives.

In 2023, the Midway Chamber sat down and thought about the future. We had last created a strategic planning document in 2019, and clearly a lot has changed since. Almost immediately, the focus of our organization had to shift to serving members impacted by both COVID-19 and civil unrest. We were fortunate we could pivot and provide necessary resources to Midway businesses, including funds and information on how to apply for loans and grants like the Paycheck Protection Program.

Despite the focus change, we were able to accomplish a lot from our previous plan. It was outward-facing with five directives: People, Careers, Community, Commerce and Environment. Through the plan, meeting with leaders at organizations in our community was prioritized. We also worked on helping define a narrative of the Midway and attempted to create a more business-friendly environment. The Chamber raised up the work of those

making the Midway a more sustainable neighborhood.

Last year, as we looked at our directives, we thought about how we can continue to build a stronger Midway through our work. We hired local small business Mighty Consulting to help us create the next plan which would take us through 2026. Here are the four main focus areas we discovered.

Community

Any Chamber of Commerce must be in tune with their community and its needs. The Midway is a unique place we love, and our hope is to create “a strong community of businesses and organizations connected to a thriving Midway.” Here are three ways we strive to build that strong community.

1 Create opportunities for authentic relationships and community-building among members. Our members enjoy attending events and getting to know one another. They also appreciate opportunities to meet the greater Midway community.

2 Serve as stewards and champions of the Midway neighborhood improvement efforts. In 2023, the Midway Chamber was part of a coalition which helped secure funding at the state for businesses along commercial corridors most impacted by civil unrest in 2020. These funds are available both by loans and grants through partners MEDA and Neighborhood Development Center. Our hope is these funds will help create a brighter future for our small businesses which will allow growth for many years to come. As other opportunities are created, we continue to promote new funds for our businesses.

Local non profits are featured at each Chamber luncheon. One month at Carondelet, FamilyWise representatives talked with attendees about the work they do in the community.

3 Promote reputation of a fun chamber through socializing, encouraging fun, and promoting camaraderie. The Midway Chamber has had a reputation for many years of having fun, and that’s part of what makes our members stay engaged. Like the Midway itself, the Midway Chamber is down-to-earth and welcomes everyone.

Education

One of the most important parts of the Midway Chamber is the opportunity to learn, which is why we are “A business community engaged and informed on important local issues and relevant topics.” Three ways in which we provide educational opportunities include:

- 1 Quality programming on topics that inform, educate, and offer relevant content for a diverse membership.**
- 2 Offer convenings on local issues to raise awareness, present diverse perspectives, and empower businesses to engage in policy and decision-making.**
- 3 Provide a variety of formats and tools for education to increase accessibility and meet members where they are at.**

Over the past year our members have heard speakers on topics including the proposed Saint Paul sales tax, artificial intelligence, multiple generations in the workforce, new labor laws, and more. While the Midway Chamber can take positions on important issues, we oftentimes also act as an educator and provide information on a subject from experts.

Looking at the work we do through the lens of community, education, membership and partnerships will help us be an efficient and effective organization.

People often ask for predictions of what University Avenue and the Midway will look like in five or 10 years. If we look back five or 10 years ago, the transformation is enormous, perhaps most notably by the Green Line, the A-Line Bus Rapid Transit and Allianz Field. The future will see development around Allianz Field, both at United Village and beyond.

The significant increase in housing along University Avenue has also played a factor in shaping our community this century, beginning with the Episcopal Homes development at Fairview and University. Multi-tenant and mixed-use buildings have been popping up ever since, especially near Green Line stations. We will continue to see more density as our community becomes more walkable.

The Midway Chamber was founded in 1919 and our community has seen many changes. We look forward to helping shape the future with our many partners. ❖

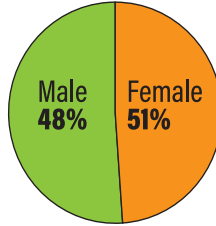

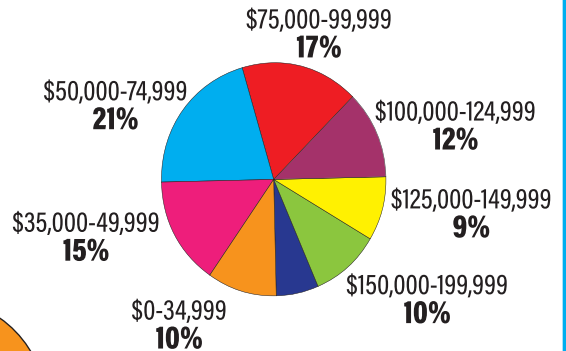
Age Range



Gender



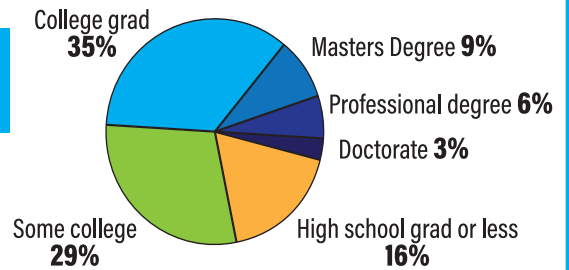
